



# The 2020 Development Cooperation Forum (New York, 14-15 May 2020)

The Development Cooperation Forum works to advance the strategic role of development cooperation in achieving the 2030 Agenda for Sustainable Development and Addis Ababa Action Agenda. The DCF is the UN platform for action-oriented reviews of the latest trends, progress and emerging issues in development cooperation, facilitating coherence among diverse actors and activities. It gives special emphasis to strengthening development cooperation to better support the needs and priorities of countries and population groups with least resources and weakest capacities. The DCF Surveys provide a ground-level view on the state of play in effectiveness of development cooperation and support the design and use of integrated national financing frameworks. The 2020 DCF High-level Meeting will focus on development cooperation as a gamechanger in the Decade of Action to deliver the SDGs.

### **Objectives:**

- Inspire a wave of innovative development cooperation policies and activities to propel progress throughout the Decade of Action, leaving no one behind.
- Build resilience through more risk-informed and climate-sensitive development cooperation.
- Advance understanding of demographic dynamics and changing patterns of development cooperation.
- Boost ODA quantity, quality and impact and catalyze all forms of development cooperation in strengthening national capacities for resource mobilization and for data and statistics.
- Leverage and learn from South-South and triangular cooperation for sustainable development.
- Strengthen trust among development cooperation actors, including local communities, by promoting a results-focus and mutual accountability.

#### Actors

- The President of ECOSOC will convene the 2020 high-level meeting of the DCF in New York on 14-15 May, back-to-back with the Multi-stakeholder Forum on Science, Technology and Innovation.
- The 2020 DCF welcomes all UN Member States and the range of non-government actors, including civil society, private sector, philanthropic foundations, women, youth and other vulnerable groups, plus members of Parliament, mayors and other local authorities, international organizations and development banks.

#### **Outcomes:**

- Concrete guidance to policymakers and practitioners to enhance development cooperation in line with the 2030 and Addis Agendas, Paris Agreement on Climate Change and Sendai Framework for Disaster Risk Reduction.
- Value-added discussion and new evidence that directly inform intergovernmental processes, influence global policy dialogue and promote broad consensus.
- Peer-learning, knowledge-sharing and partnership-building, including on enablers of effective development cooperation as key building blocks of integrated national financing frameworks.

**2019-2020 DCF Survey Study** draws on the data from the biennial DCF Survey on the state of play in effectiveness of development cooperation on the ground. The 6<sup>th</sup> survey is underway, with the study to be published prior to the 2020 DCF.

## The DCF: A distinctive, dynamic and trusted platform for dialogue and results

- Direct uptake of DCF input to UN decision-making bodies: As the designated focal point of the UN system for holistic consideration of international development cooperation, outcomes of the DCF are channeled to other key inter-governmental processes, such as the High-level Political Forum on Sustainable Development (HLPF) and ECOSOC Forum on Financing for Development, through established mandates. The DCF forms an integral part of the global architecture for achieving the 2030 Agenda and Addis Agenda.
- A platform for action-oriented policies: The DCF is known for offering: (i) policy recommendations, with the Forum as a function of UN ECOSOC operating at global level; and (ii) action-oriented, concrete policy guidance on common issues related to development cooperation for policy makers and practitioners working at the regional, national and subnational levels. The DCF also helps to identify capacity support needs of countries and provides context-specific policy insights.
- Trusted space for exchange among all governments and diversity of actors: The DCF is both a platform and policy & practice community, open to all UN Member States and the range of non-government actors, including civil society, private sector, women, youth and other vulnerable groups, as well as members of Parliament and local authorities. The DCF also works with other platforms within the UN and beyond to ensure complementarity of its work, such as the Global Partnership for Effective Development Cooperation (GPEDC), which focuses on supporting country-level implementation of the Busan principles.
- **Evidence-based knowledge sharing and mutual learning:** A founding aspiration of the DCF is to foster candid conversations, grounded in evidence, and build authentic partnerships and trust. In this context, the DCF Survey exercise guarantees the confidentiality of participating countries to encourage frank sharing. In its wider analytical work and policy dialogue, the DCF brings global attention to contextualized country examples. This includes examples that illuminate how key enablers of effective development cooperation can serve as essential building blocks of integrated national financing frameworks (INFFs) and optimal mobilization and management of financial and non-financial resources to achieve national sustainable development strategies.
- **Demand-driven, agile and persistent:** The DCF's priority themes and policy directions are driven by real needs and concerns on the ground. The 2020 DCF will be preceded by a multi-stakeholder DCF Symposium and other DCF-related events and analytical work to bring that reality check to the policy dialogue. After the high-level meeting, the outcomes of the 2020 DCF will be carried forward through knowledge-sharing and peer-learning activities, including by channeling DCF policy recommendations through other forums, side events and other activities to engage the development cooperation policy & practice community.
