# H.E. Mr. Munir Akram

His Excellency Munir Akram was elected seventy-sixth President of the Economic and Social Council on 23 July 2020. Ambassador Akram is currently the Ambassador and Permanent Representative of Pakistan to the United Nations in New York. Ambassador Akram assumed his position as Permanent Representative of Pakistan to the United Nations, with the rank of Ambassador Extraordinary and Plenipotentiary, on

November 1, 2019. Ambassador Munir Akram previously served as Pakistan's Ambassador and Permanent Representative to the United Nations in New York for six years between 2002 and 2008, after serving as Ambassador and Permanent Representative to the United Nations in Geneva for seven years from 1995 to 2002.

Mr. Eric Nii Yarboi Mensah is Assistant Commissioner in charge of Legal Affairs and International Taxation Agreements at the Ghana Revenue Authority. He previously was Legal Officer, Ghana Revenue Authority. Mr. Mensah has a Bachelor's Degree in Sociology and Political Science, University of Ghana, a Qualifying Certificate in Law, Ghana School of Law and a Certificate in Business Tax and Modernising Tax Administration, University of Pretoria, South Africa.



# Ms. Carmel Peters

Ms. Carmel Peters is Policy Manager, Inland Revenue, New Zealand. Her previous positions include Senior Policy Analyst and Senior Policy Advisor at Inland Revenue, New Zealand. She also was Senior Associate at Rudd Watts & Stone law firm. Ms. Peters holds a Master's Degree in Law (Taxation), New York University, USA and a Bachelor's Degree in Law, Victoria University of Wellington, New Zealand.



### Mr. Liu Zhenmin

Appointed on 26 July 2017, Mr. Liu Zhenmin of China serves as the Under-Secretary-General for Economic and Social Affairs. Prior to his appointment, Mr. Liu was Vice-Minister for Foreign Affairs of China since 2013. Among his various diplomatic assignments, he served as Ambassador and Permanent Representative, Permanent Mission of the People's Republic of China to the United Nations Office at Geneva and Other International Organizations in Switzerland (2011-2013). Mr. Liu brings to the position more than 30 years of experience in the diplomatic

service, with a strong focus on the promotion of bilateral, regional and global issues. He was deeply involved for 10 years in climate change negotiations including the conclusion of the Kyoto Protocol and the Paris Agreement. He also widely participated in the international activities on the protection of our planet including Antarctica and the oceans. Over the last several years, in various capacities, he has been consistently highlighting and advocating for sustainable development issues.



# Prof. Annet Wanyana Oguttu

Annet Wanyana Oguttu is a professor of tax law in the department of taxation and the African Tax Institute at the University of Pretoria. She holds a Doctorate in tax law. Her field of specialisation is International Tax Law. She has published many articles on topics in this field in various internationally accredited journals. She authored the book "International Tax Law: Offshore Tax Avoidance in South Africa" (Juta, 2015), is a co-author of "Tax Law: An Introduction" (Juta, 2020),

and has also written several book chapters in other tax law books. Prof Oguttu is member of the UN High-Level Panel on International Financial Accountability, Transparency and Integrity for Achieving the 2030 Agenda for Sustainable Development (FACTI Panel). She is the BEPS Chair of South Africa's Davis Tax Committee; has been a Commissioner of the South African Law Reform Commission; and is a board member of The Tax Faculty and of the African Tax Research Network that is based at the African Tax Administration Forum.

## H.E. Mr. Sergiy Kyslytsya

Sergiv Kyslytsya is the Ambassador Extraordinary Plenipotentiary and Permanent Representative of Ukraine to the United Nations in New York. Before his latest appointment, Mr. Kyslytsya was his country's Deputy Foreign Minister since 2014. He was previously Director-General for International Organizations at the Ministry of Foreign Affairs beginning in 2006 until 2014 and Deputy Director-General of the Ministry's Second Territorial Department (Americas and Western

Europe) in 2006. Mr. Kyslytsya was Minister Counsellor for Political Affairs at Ukraine's Embassy in Washington, D.C., between 2003 and 2005, having served as Political Counsellor in the same mission from 2001 until 2003. Among other positions, Mr. Kyslytsya was Chief of Staff to the Minister for Foreign Affairs, as well as First Secretary (Political) at Ukraine's Embassy in Belgium, accredited also to the Netherlands and Luxembourg, as well as its Mission to the North Atlantic Treaty Organization (NATO). He was previously the Head ad interim of the Foreign Ministry's Council of Europe Section. Mr. Kyslytsya holds a master's degree in international law.



### **Prof. Stephen Shay**

Stephen Shay is a tax lawyer, teacher and researcher specializing in international taxation. Mr. Shay is an adjunct professor at Boston College Law School, consults for international organizations and private parties and has testified as an expert before judicial and arbitral tribunals on behalf of governments and private parties. Mr. Shay has been a Professor of Practice at Harvard Law School and a Lecturer at

Yale Law School, University of Oxford (United Kingdom) and the Leiden International Tax Institute (The Netherlands). Mr. Shay was Deputy Assistant Secretary for International Tax Affairs in the United States Department of the Treasury from 2009 to 2011 and in private practice as a tax partner with Ropes & Gray, LLP from 1987 to 2009. Mr. Shay is a 1972





















graduate of Wesleyan University, and he earned his J.D. and his M.B.A. from Columbia University in 1976.



# Ms. Liselott Kana

Liselott Kana is a graduate of Stockholm University, and in 1984 she obtained a Master of Law degree from the London School of Economics. She worked in London for Arthur Andersen & Co until 1989, and since 1990 she has been involved as a public official with international issues in Chile. In 1997, she was appointed Head of International Taxation in charge of negotiating taxation treaties at the Internal Revenue Service of Chile. She was a member of the Permanent Scientific Committee of the

International Fiscal Association (IFA) until 2008 and was a founder and president of the IFA branch of Chile in 2004. She has also been a president of IFA Latin America and a member of the United Nations Committee of Experts on International Cooperation in Tax Matters until 2017. She is a delegate for Chile to the taxation work at the OECD. She also teaches international tax at the Catholic University in Santiago and at the Vienna Akademie der Wirtschaftstreuhänder in Austria.



# Ms. Elfrieda Stewart Tamba

Elfrieda Stewart Tamba was formerly Commissioner General, Liberia Revenue Authority. Her previous positions include Deputy Minister of Revenue, Ministry of Finance, Monrovia, Liberia and Chief Financial Officer, Liberia Bank for Development and Investment, Monrovia, Liberia. Ms. Tamba has a Bachelor's Degree in Business Administration,

Cutting University College, Gbarnga, Liberia and a Master of Business Administration in Finance, Morgan State University, Baltimore, MD, USA. Ms. Tamba also serves on the United Nations Committee of Experts on International Cooperation in Tax Matters.



#### Mr. Pascal Saint-Amans

Pascal Saint-Amans is the Director of the Centre for Tax Policy and Administration at the OECD. Mr. Saint-Amans, a French national, joined the OECD in September 2007 where he played a key role in the advancement of the OECD tax transparency agenda in the context of the G20. Prior to his appointment as Director, he was the Head of the Global Forum on Transparency and Exchange of Information for Tax Purposes since 2009. Mr. Saint-Amans graduated from the National

School of Administration (ENA) in 1996 and was an official in the French Ministry for Finance for nearly a decade.

### Prof. Joseph E. Stiglitz

Professor Joseph E. Stiglitz is an American economist and a professor at Columbia University. He is the co-chair of the High-Level Expert Group on the Measurement of Economic Performance and Social Progress at the OECD, and the Chief Economist of the Roosevelt Institute. A recipient of the Nobel Memorial Prize in Economic Sciences (2001), he is a former senior vice president and chief economist of the World Bank and a former chairman of the Council of Economic Advisers. In 2000, Prof. Stiglitz

founded the Initiative for Policy Dialogue, a think tank on international development based at Columbia University. In 2011, he was named by Time as one of the 100 most influential people in the world. Known for his pioneering work on asymmetric information, Stiglitz's research focuses on income distribution, risk, corporate governance, public policy, macroeconomics and globalization. Aside from the current position, Mrs. Mongkhonvanit also has strong expertise in tax administration. She was one of the top executives in the

Revenue Department of Thailand that initiated key domestic and international tax policies. She is a member of the United Nations Committee of Experts on International Cooperation in Tax Matters since 2016. Mrs. Mongkhonvanit holds a B.A. in Political Science from Chulalongkorn University, Thailand, an M.A. in Economics Development from the University of Wisconsin-Madison, U.S.A., and an LL.M. in Tax from the London School of Economics and Political Science, U.K.



# Mr. Kurt Van Dender

Kurt Van Dender is Head of the Tax and Environment Unit at the OECD's Centre for Tax Policy and Administration. Prior to joining the OECD Centre for Tax Policy and Administration, Kurt was the Chief Economist of the International Transport Forum and Professor of Economics at the University of California at Irvine. He came to Norad after one and a half years as Secretary General of World Wide Fund for Nature Norway.
