Excellency,

We thank you for participating in the 6th Development Cooperation Forum (DCF) Survey of progress in national mutual accountability and transparency, conducted by the United Nations Department of Economic and Social Affairs (UNDESA).

Participants value the DCF Survey for promoting candid dialogue on international development cooperation, mutual learning among stakeholders, and improved coordination within governments and with international development cooperation partners. This has increased transparency of development cooperation information, fostered knowledge exchange between countries and improved monitoring, review and accountability of development cooperation. The survey process encourages and supports consultation between Ministries and domestic actors and beneficiaries in developing countries, and their international development cooperation partners.

The DCF Survey is structured around key enablers of effective development cooperation, such as National Development Cooperation Policies (NDCPs), country-driven results frameworks, clear institutional structures with dialogue forums, quality information on development cooperation, and capacity support. These enablers can serve as building blocks in designing and implementing integrated national financing frameworks (INFFs) and optimal mobilization and management of financial and non-financial resources to achieve national sustainable development strategies.

Confidential country responses and inputs directly feed, without attribution, into the UN-led intergovernmental and interagency processes and reports. These include the Development Cooperation Forum, ECOSOC Forum on Financing for Development and the High-level Political Forum on Sustainable Development, as well as the Report of the Secretary-General to the DCF and the Financing for Sustainable Development Report (FSDR) by the Inter-Agency Task Force (IATF). The groundwork laid by countries completing this survey also facilitates preparation and follow-up of the Voluntary National Reviews of progress toward the Sustainable Development Goals (SDGs).

- Engage different stakeholders in the preparation of responses, including parliamentarians. The lead Ministry is encouraged to liaise with the UN Resident Coordinator's Office to explore opportunities in this regard.

 - 1. National Development Cooperation Policy: this could be named differently by the country (e.g. National Aid Policy, National Development Assistance Policy, National Partnership Policy, etc.)
 - 2. National Sustainable Development Strategy/Plan or similar document
 - 3. Supporting documents for National Development Cooperation Forums (e.g. reviews/analyses of progress)
 - 4. Country Results Frameworks/other monitoring frameworks or national documents with international development cooperation targets, including INFFs.
- Submit the survey online by **13 December 2019**.

All responses are confidential: results will be aggregated and cannot be linked to your country, except in cases where prior consent has explicitly been given. Findings will be presented in the 2020 DCF Survey Study, to be launched in advance of the 2020 Development Cooperation Forum to be held in New York on 14-15 May 2020.

Why should you engage in the survey exercise?

National mechanisms that hold actors accountable for development cooperation bring specific value:

- Contribute to design and operationalization of integrated national financing frameworks.
- Make financial resources and cooperation more adequate, predictable and targeted towards achieving the SDGs.
- Lead to greater use of country systems, budget support and transparent use of funding.
- Solidify trust between governments, domestic actors and beneficiaries, and their development cooperation partners.

What have participating countries shared about their survey experience?

Participating countries have reported that the DCF surveys:

- Promote frank dialogue on development cooperation.
- Improve coordination within governments and with development cooperation partners.
- Clarify monitoring, review and accountability of development cooperation.
- Facilitate mutual learning among stakeholders.

The DCF Survey assists governments in assessing how effectively their development cooperation works in support of their national sustainable development priorities. It is structured around five practical enablers of effective development cooperation, (i) national development cooperation policies, (ii) country results frameworks, (iii) national development cooperation forums, (iv) development cooperation information systems, and (v) support for capacity development.

A: NATIONAL DEVELOPMENT COOPERATION POLICY (NDCP)

The national development cooperation policy (NDCP) defines what effective development cooperation means in each country context, including in the area of mutual accountability and transparency among all cooperation actors. The NDCP articulates a country's vision, priorities and activities related to international development cooperation as well as the division of labour among all relevant actors. The NDCP can either be a stand-alone document or part of a national action or development plan or an integrated national financing framework (INFF). When it is a separate document, it is typically called "aid policy", "development assistance policy", "partnership strategy', or similar.




