

Twenty-seventh Session of the Committee of Experts on International Cooperation in Tax Matters Geneva, Switzerland, 17-20 October 2023



General Information Note

Dates and Venue

The twenty-seventh session of the Committee of Experts on International Cooperation in Tax Matters will take place at the Palais des Nations in Geneva, Switzerland, from 17 to 20 October 2023. The meeting will be held in **Conference Room XIX, located on the 3rd floor of the New Building of the Palais (Batiment E)**, which is accessible through outer doors marked “Porte 40” of the Palais.

The session has the mandated meeting hours daily of 10:00 a.m. to 1:00 p.m. and 3:00 p.m. to 6:00 p.m. The session will be held in-person with the support of conference servicing at the Palais, including simultaneous interpretation services.

The session will be held in-person, including simultaneous interpretation into the official UN languages, with provision also made for virtual participation by observers. Prior registration is required for logistical and security reasons (separate for in-person and virtual attendance, see further information below).

Note: Please be advised this will be a “paperless” meeting and all conference documents will be made available only in electronic format. Please check the [website](#) regularly for updates. Kindly note that photocopying facilities will not be available to us in Geneva.
