# **Background**

The SDG Investment Fair, launched in 2018, has evolved from an annual event to a continuous platform for knowledge sharing and partnership building. It fills a gap in the marketplace with an inclusive space to network, exchange and kickstart engagements around investable opportunities in the SDGs that are presented by participating countries. To date, over 130 projects worth more than USD 50 billion have been showcased at the Fair, the majority of which have focused on sustainable infrastructure (particularly in transportation and housing/construction sectors), and clean energy. For cases and details, refer to the Fair Portfolio Overview Report and a recent information brief.

Despite the high level of demand from Member States, lack of capacities in identifying, assessing, and preparing bankable sustainable investment projects as well as low understanding on how to access international capital markets and the prerequisites for private participation in public-backed infrastructure project finance, has hindered more accelerated SDG progress in many countries. While traditional financing instruments such as 'green' and other sustainability-linked bond, sukuk and loan products remain the most significant potential source of private investment for SDG action, many countries, particularly those in special circumstances, require greater practical know-how in the processes, requirements, and benchmarks required to utilize them at scale. Moreover, a stronger understanding of how to liaise with investors, credit rating agencies, guarantee agencies, and other capital market players more effectively would faciltate access to finance.

#### **Objective**

The purpose of this 3-hour workshop is to strengthen developing countries' capacities to mobilize private investment and finance their SDG projects. It will build countries' knowledge of alternative potential development financing sources and leveraging using public and private resources.

This workshop is organized into four modules: (Project Preparation, Debt Capital Markets, Project Finance Risk Management, and Storytelling and Execution). Workshop facilitators include, but not limited to, private and public sector practitioners in Project Finance, Debt Capital Markets and experts in regulation and legal.

Planners and government officials in developing countries in charge of investment project preparation and investment facilitation have also expressed the need to better understand the landscape of private financiers and development banks, to





more effectively access all available opportunities to mobilize resource and preinvestment support to realize their projects at the stage of pre-investment closure.

# **Participants:**

The main audience for the workshop is representatives from participating Member States. It targets planning and investment officers responsible for conceptualizing, assessing, and promoting large-scale projects.

The event is by invitation only to country representatives that have engaged or plan to engage in the SDG Investment Fair platform to present investment-ready projects.
