Excellency,

In paragraph 4 (b) of General Assembly resolution 78/271 entitled “Further modalities of the Fourth International Conference on Financing for Development”, the General Assembly decided:

“To request the President of the General Assembly to draw up a list of representatives of other relevant non-governmental organizations, civil society organizations, academic institutions and the private sector who may participate in the Conference and its preparatory process, taking into account the principles of transparency and of equitable geographical representation and with due regard for gender parity, and to submit the proposed list to Member States for their consideration on a non-objection basis and bring the list to the attention of the Assembly for a final decision by the Assembly on participation in the Conference and its preparatory process.”

To this end, I have the honour to enclose herewith a list of representatives of non-governmental organizations, civil society organizations, academic institutions and the private sector, which have applied to participate in the Fourth International Conference on Financing for Development and its preparatory process.

In the absence of any objection by **5 p.m. on Wednesday, 29 May 2024**, I will take it that there is a general agreement on the list. I intend to bring the list to the attention of the General Assembly for a final decision on participation in the Conference and its preparatory process in due course.
