- Revised draft TOR contain a hybrid approach (between simultaneous and staged) to optimize coordination between the documents.
- Intergovernmental negotiating body would begin negotiating the early protocols at the same time as the framework convention.
- Additional 6 months to finish the work on the early protocols.
