# 130 Sevilla Platform for Action (SPA) initiatives

## 204 lead entities, including 65 UN Member States

43 initiative announcements at  
Sevilla

Over 80 lead entities involved in  
these announced initiatives

including 38 Member States, AU,  
EU, 5 MDBs, 12 UN entities, and  
more

Initiatives collectively contribute  
to all 7 FFD Action Areas

22 initiatives with explicit targets  
for mobilizing additional financing,  
totaling on average \$145 BN per  
year until 2035

including \$135 BN per year from  
projected tax revenue gain, and \$10  
BN in investment

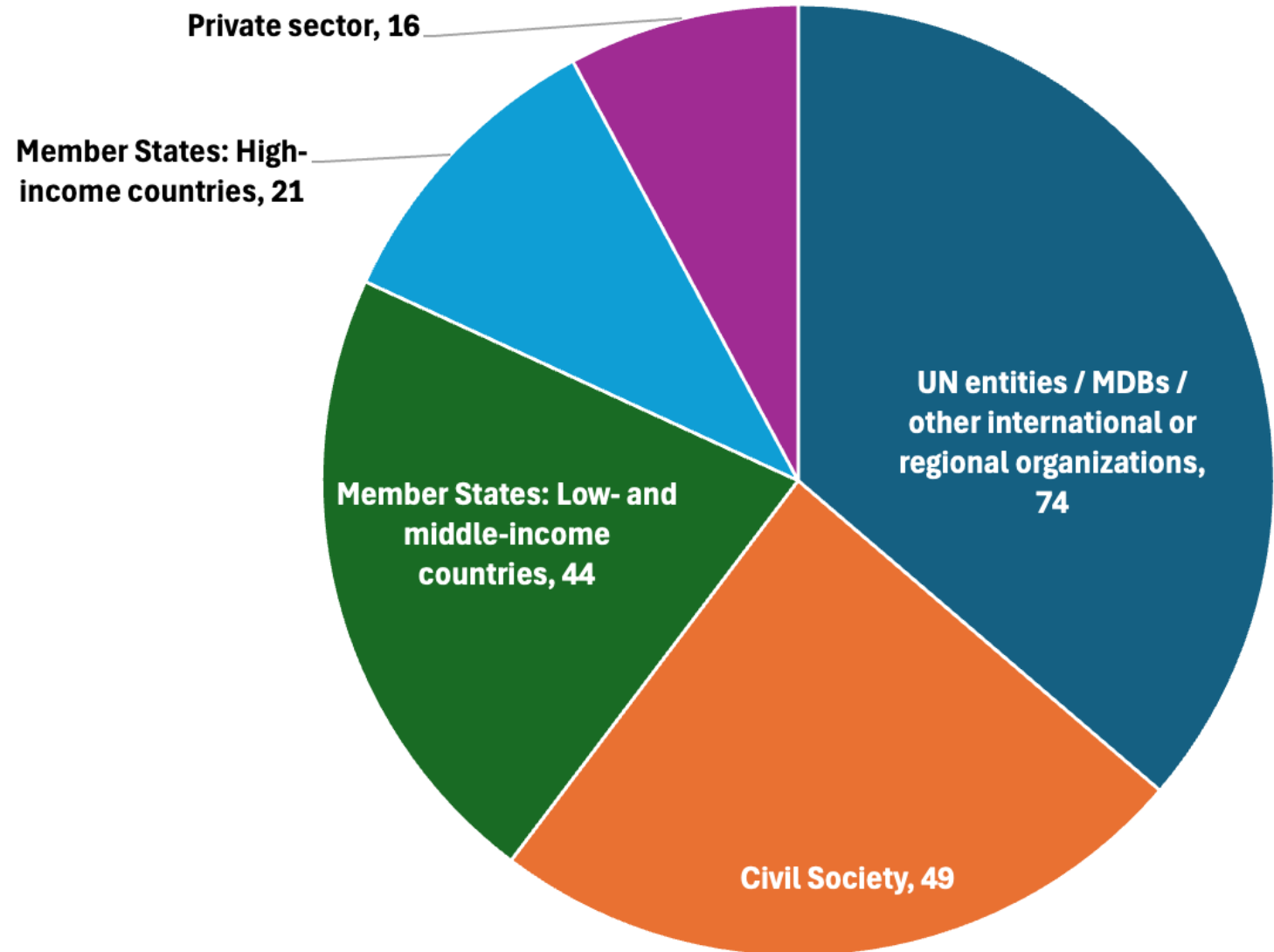

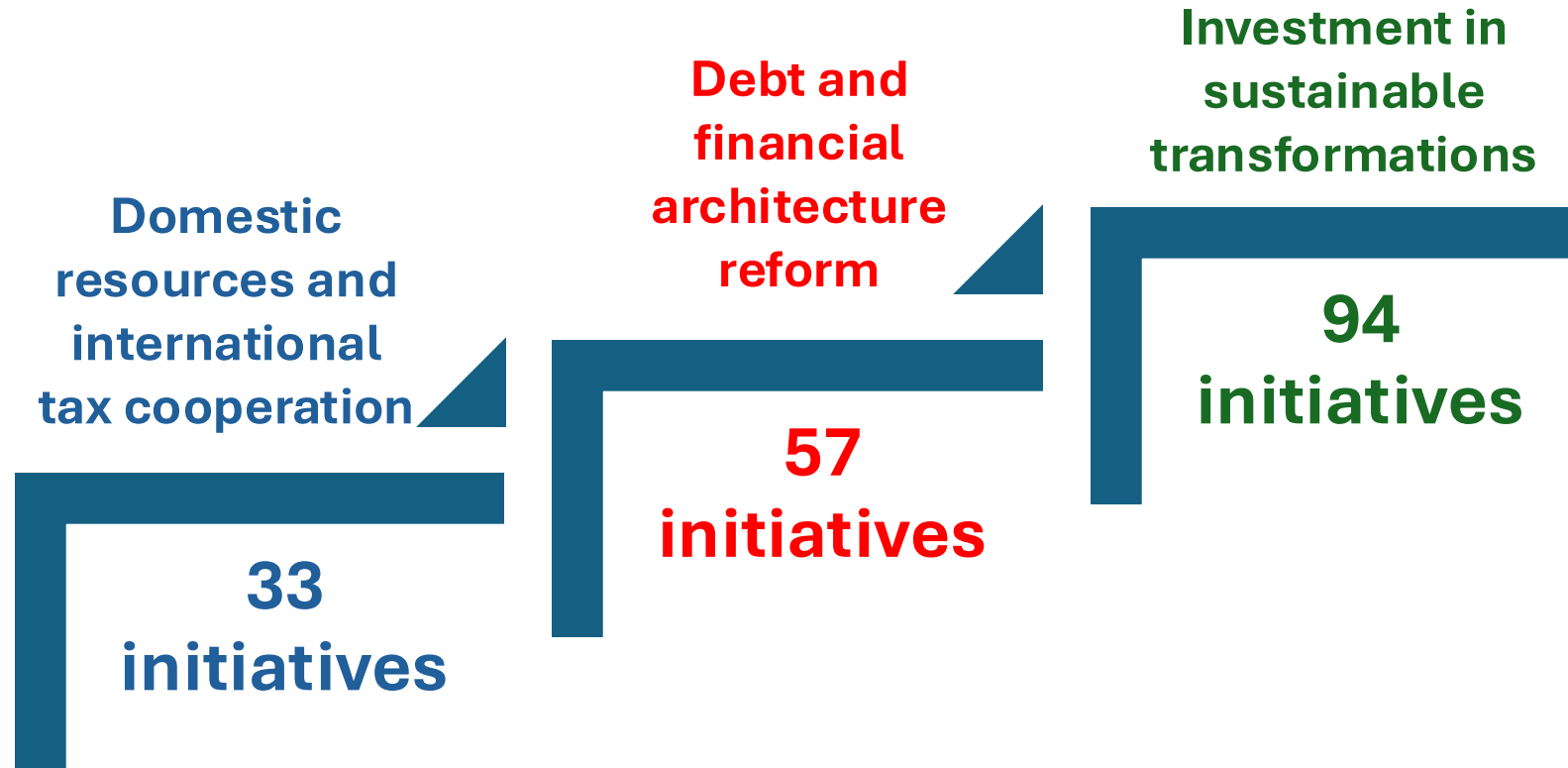


# **All SPA initiatives: Number of unique lead entities, by stakeholder type**

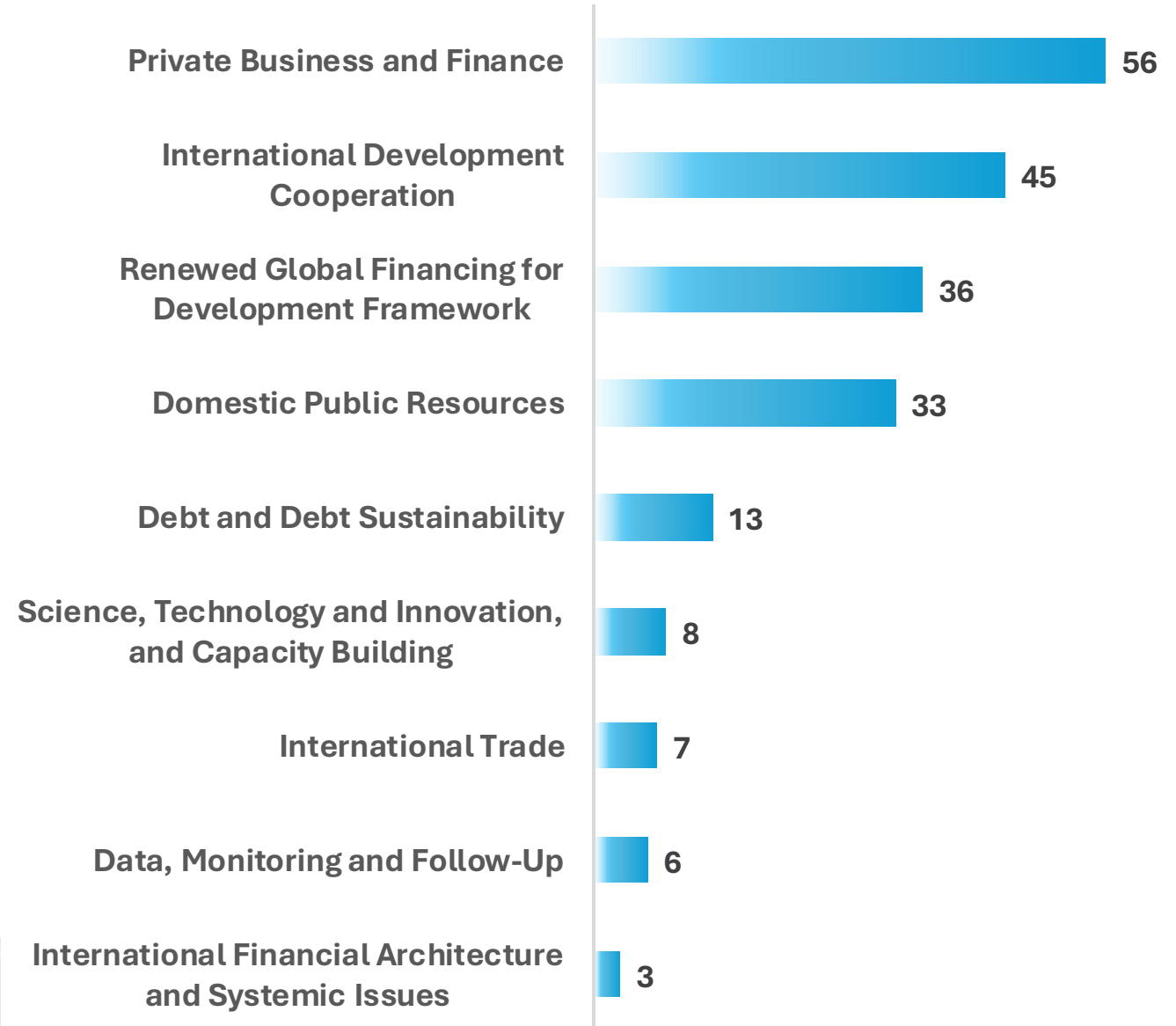

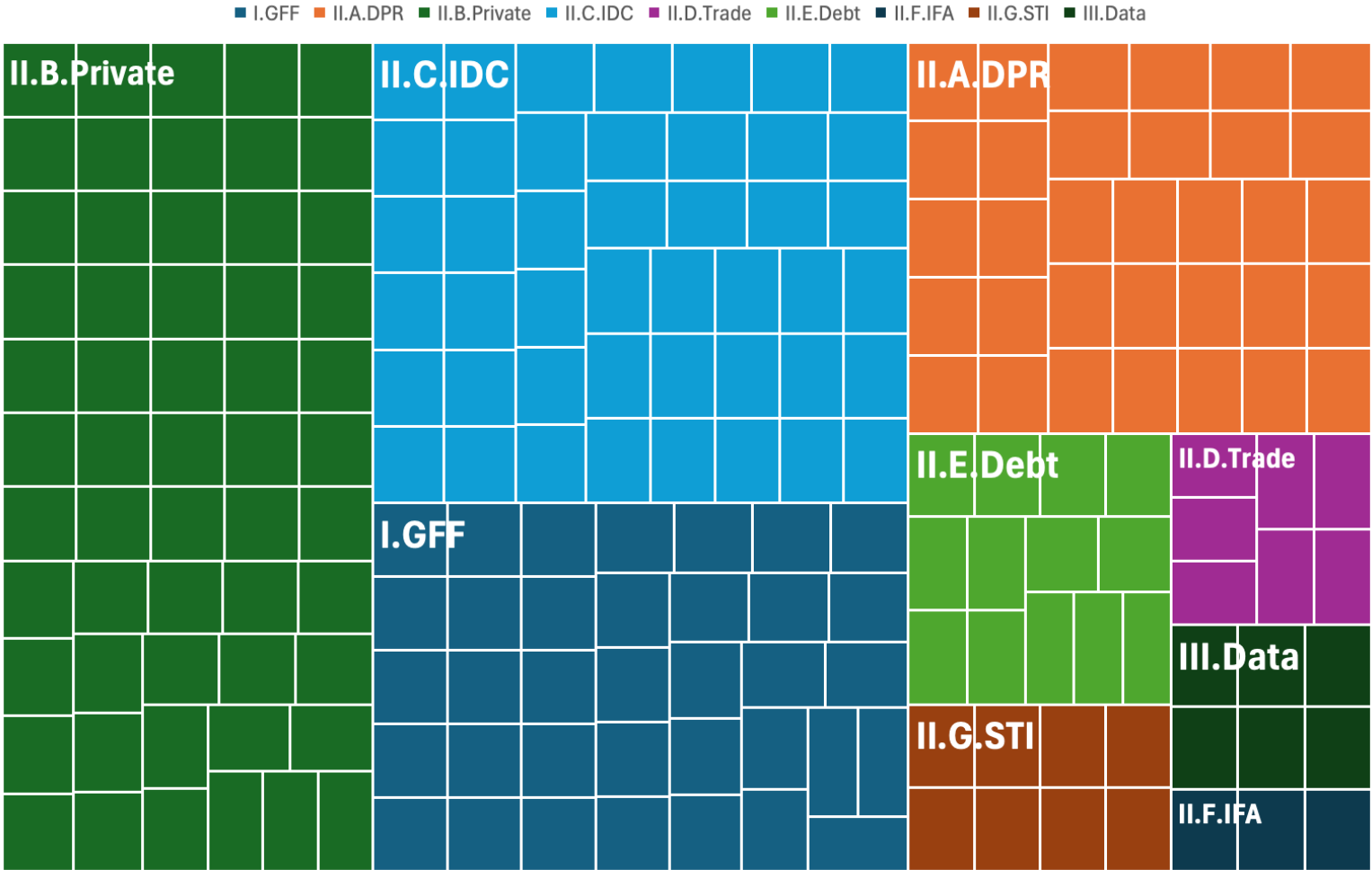


# Number of initiatives supporting actions in each chapter in the Sevilla Commitment

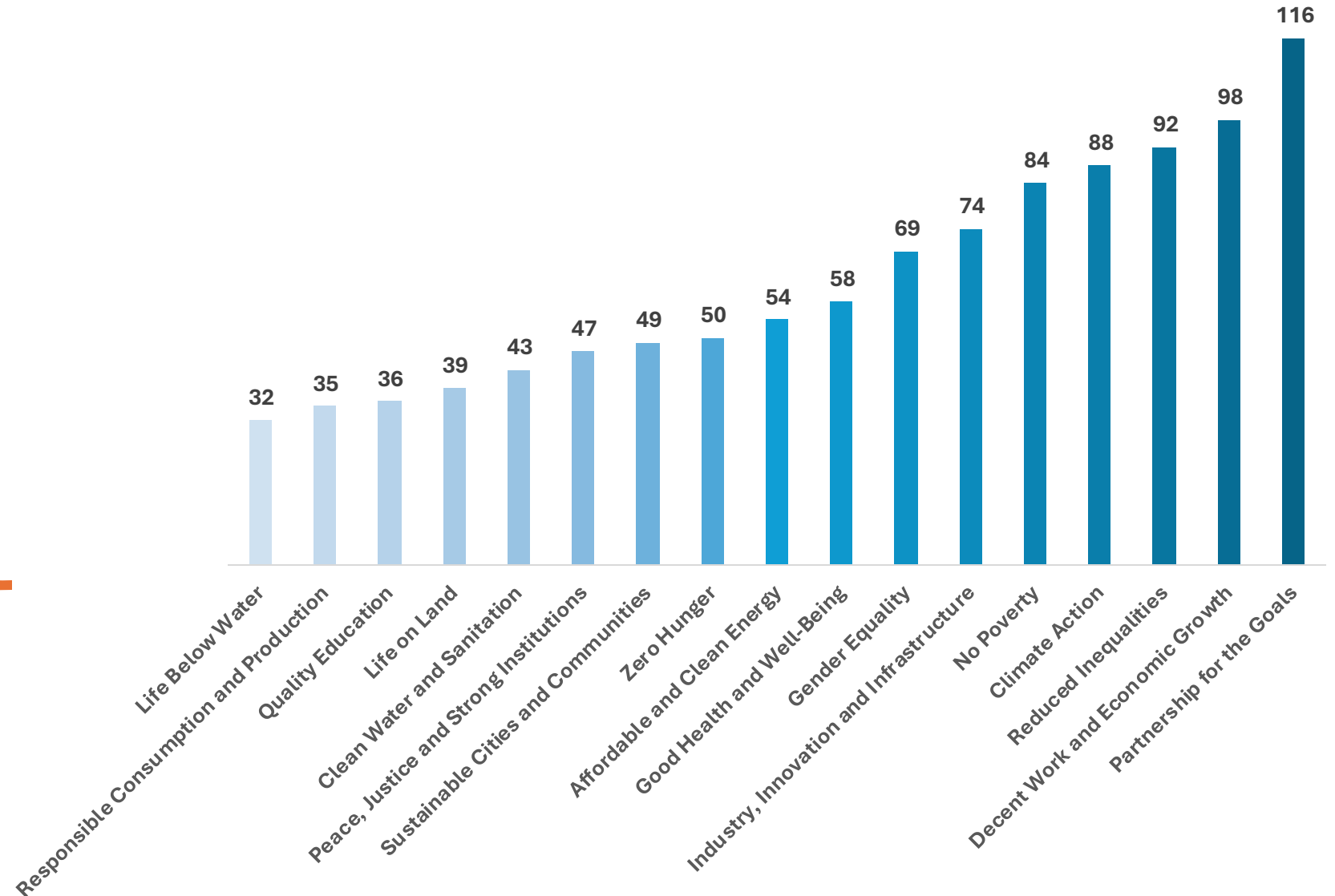
